The Parochial Church Council (PCC) of All Saints has the responsibility of co-operating with the incumbent, the Reverend Canon Susan Loxton in promoting in the ecclesiastical parish the whole mission of the Church; pastoral, evangelistic, social and ecumenical. The PCC also has maintenance responsibilities for this imposing Grade II listed church building. The surrounding churchyard is closed and the maintenance responsibility lies with the Parish Council

The Covid 19 pandemic affected the worship possible in the parish church from March 2020, when socially distancing measures were brought into effect. A robust Risk Assessment was written following Government and Church of England guidelines. This made provision for one service a month of restricted Holy Communion to be offered to the whole benefice in All Saints church and a space for supervised private prayer for the parish each Wednesday.

There were times through the year when Government ruling closed churches completely.

Revd Canon Susan Loxton had support for services from Revd Gini Williams, Curate to the Benefice and Jennifer Chetwynd, who continued as licensed Lay Elder within the Sancroft Benefice with particular support for All Saints church.

Remote worship options were developed as a Benefice which saw up to 30 households meeting through Zoom each Sunday, led and supported by the whole Benefice ministry team. Opportunities for weekday Morning Worship, prayers and an Evening Worship have been developed. These have been recorded along with each Sermon or Reflection and made available on the Sancroft Benefice website.

A new, electric heating system for the church was approved, and funds continued to be raised from the village to meet the extra cost. Work on installing the system will be considered for 2021.

The major task of re-ordering All Saints church has also been affected by circumstances of the pandemic, along with failure to secure more building grant funding.

The group Friends of All Saints Stradbroke, which drove most of the fund raising for the building, decided to close this year, but give the funds it held for the PCC to arrange the essential clerestory windows and wall repairs itemised in the Quinquennial Report from the church architect.

There was only one Funeral Service in church this year, no Baptisms or Weddings.

Church members, along with other villagers have continued to support Waveney Food Bank throughout the year with donations collected at The Rectory.

The Children's Society charity was also supported throughout the year through collecting boxes taken by individual members of the congregation and others in the village and beyond. Thanks to Alison Hackett for co-ordinating this giving, counting of monies and distribution of collection boxes.

Financial report 2019

The annual financial statements have been circulated to PCC members before this meeting and agreed as a true record. These have been checked by an independent examiner, Jamie Pretty Chartered Certified Accountants.

The main points are:

- The amount of £5,000 was paid for Parish Share to the Diocese; last payment in December 2020 for £2,000 was not presented to the bank before the year end. The full Parish Share for 2020 was not feasible; after discussion with the Deanery Chair, a compromise was agreed. By the end of the year double that amount was possible due to generous donations.
- The loss of opportunities for most planned fundraising events had an impact on funds available.
- The Fabric Fund stands at £1,392
- We have 15 regular members of the congregation who make their giving by Direct Debit each month, which helps with budgeting.
- Successful, small grant applications for essential repairs have eased the financial burden but it has taken careful budgeting and management of other costs to keep as close to solvency as possible.

Church Warden's Report

It has been a difficult year with National restrictions that have kept the church closed for services and events most of the year. There was an occasional service allowed and one day a week open for private prayer.

A robust Risk Assessment was written and kept in place following Government guidelines.

Due to personal commitments Karen has stepped down as Churchwarden; I wish to thank her for her input.

During the year the following checks/servicing were carried out:

- Lightning Conductor
- Roof Alarm
- Gutters and drainage repairs required to the tower turret to be actioned in 2021.

<u>Projects:</u>

- 1. The new church electrical heating installation will be started in 2021, ready for the winter months.
- 2. Preparations for repairs to the South clerestory wall and realignment of windows were started by the church architect, Nick Warnes. A faculty has been applied for and tenders to approved contractors are waiting for confirmation.

Project two is being funded by the Friends of All Saints, Stradbroke which will be their last before being disbanded. I wish to thank them for their support over the years, as their contributions have been invaluable.

Deanery Synod report

Hoxne and Hartismere Deaneries met with a special open Zoom meeting on Weds 21st October 2020 to discuss a proposal to merge both Deaneries. A poll after frank questions and answers gave 42% in favour of a merger. The Rural Dean and Lay Chairs took a report of this meeting for discussion at the November

meeting of Suffolk Archdeanery Mission & pastoral Committee. This committee would then consult with both PCCs.

Meeting by Zoom on 14th November 2020 focused on Parish Share and the ability for Parishes to meet the current year Share as well as proposals for 2021. All Parishes were reassured that individual discussions with the Lay Chair would be frank about a fair estimate of the portion possible for 2020. Various feasable options were discussed for full payment in 2021.

The impact of the Government guidelines for dealing with Covid 19 through most of 2020 meant no events could be held after March 2020. Only £207 was raised this year in contrast to the usual £5,000

The failure to secure substantial funding from Historic England for the church was the final blow to members' morale. Subsequently, FOASS gave notice to the PCC that we have decided to cease to work to raise further funds. The current funds held of just over £50,000 would be given over to the PCC to continue the agreed repairs on the clerestory wall and windows.
